INTERLOCAL CONTRACT FOR REGULATION OF FOOD SERVICE ESTABLISHMENTS

This Contract is by and between the County Of Brazoria, a political subdivision of the State of Texas ("COUNTY"), acting by its County Judge, as duly authorized by the Commissioners Court of COUNTY and the Village of Surfside Beach ("MUNICIPALITY"), Texas, a municipality located within Brazoria County, Texas, acting by its mayor as duly authorized by its governing body (hereinafter referred to as "MUNICIPALITY").

PREAMBLE

WHEREAS, Tex. Gov. Code 791.011, the Interlocal Cooperation Act, provides that any local government may contract with another local government to perform governmental functions and services; and

WHEREAS, the Interlocal Cooperation Act 791.003 states that "governmental functions and services" means any function or service including general area of public health and welfare which is of mutual concern to the contracting parties; and

WHEREAS, the Interlocal Cooperation Act 791.012 recognizes that the authority of COUNTY to perform a contractual service for MUNICIPALITY includes the authority of COUNTY to apply the rules, regulations, and orders of COUNTY; and

WHEREAS, Tex. Health & Safety Code 437.003 provides that to enforce state law and rules adopted under state law, the Commissioners Court of a county by order may require food services establishments, retail food stores, mobile food units, and roadside food vendors to obtain a permit from the county and such requirement was duly adopted by the Commissioners Court of COUNTY on September 11, 2007, by Order No.

35, titled "Brazoria County Health Department Regulations on the Permitting of Retail Food Stores and Food Services Establishments" ("The Rules"), which are incorporated in their entirety into this contract by reference; and

WHEREAS, Tex. Health & Safety Code 437.002 provides that COUNTY may enforce state law and rules adopted under state law concerning food service establishments, retail food stores, mobile food units, and roadside vendors; and

WHEREAS, the Texas Department of State Health Services has adopted rules pertaining to food service establishments which shall be liberally construed and applied to promote their underlying purpose of protecting the public health; and

WHEREAS, parties have determined that the implementation of this Contract is in the interest of and for the public health, safety, and welfare of their residents; and

WHEREAS, the parties have determined that they are authorized to enter into this contract pursuant to law and their general powers to contract.

NOW, THEREFORE, for and in consideration of the promise, covenants, and obligations set forth below, the parties agree as follows:

T.

GENERAL STATEMENT

The matters set forth in the foregoing preamble are true and correct to the best knowledge of the parties and constitute material representations by the parties.

II.

SERVICES

COUNTY shall issue permits to food service establishments, retail food stores, mobile food units, and roadside food vendors within the incorporated limits of

MUNICIPALITY while this Contract is in effect. The Rules shall govern procedures and requirements for the issuance of permits.

III.

CONSIDERATION

As compensation for the services performed by COUNTY under this Contract,
COUNTY through its Health Department shall collect permit and other fees as provided
by the rules. All fees shall be payable and belong solely to COUNTY. The
Commissioners Court of COUNTY hereby finds that the fees so collected fairly
compensate COUNTY for the services performed.

IV.

LEGAL REPRESENTATION

Any suit brought to enjoin any activity occurring within the incorporated limits of MUNICIPALITY in violation of the Rules shall be the responsibility and at the expense of MUNICIPALITY. Any criminal offense in violation of the Rules shall be prosecuted by COUNTY through its District Attorney in the appropriate Justice of the Peace Court.

V.

TERMS AND EFFECTIVE DATE

The initial term of this Contract is one year from the date signed by the Brazoria County Judge provided, however, that this Contract shall de automatically extended for periods of one year each unless either party gives the other party thirty (30) days written notice before the expiration of the contract period that such party desires to terminate this Contract, in which event Contract shall terminate at the end of that one year period. Additionally, either party may, at any time during the contract term, terminate this

Contract by delivering thirty (30) days written notice such intention, whereupon, on the date specified, this Contract shall automatically terminate.

VI.

NOTICES

All notices to be given under this Contract shall be written and sent certified or registered U.S. mail, of shall be hand delivered with proof of delivery obtained, as follows:

VII.

INDEMNIFICATION

MUNICIPALITY shall fully indemnify, hold harmless, and defend COUNTY, its departments, officers, agents, and employees from and against and all loss, injury, damage, demand, obligation, liability, claim, court cost, and attorney's fee, including those arising from personal injury or death, arising out of or in any manner related to the performance by COUNTY of the services described in this Contract.

V III.

NON-ASSIGNMENT

This agreement is not assignable by either party.

XI.

FORCE MAJEURE

If the performance of any covenant, agreement, of undertaking contained in this Contract is delayed by war, civil commotion, act of God, governmental regulation (except as imposed by COUNTY), fire or other casualty, or any other circumstances beyond the control of the party obligated to such performance, the party shall be excused from performance during the period of delay.

X.

MISCELLANEOUS

The captions of titles of these articles of this Contract are inserted for convenience only, and shall not be considered a part hereof, nor in any way serve to modify or restrict any term or provision hereof, nor be considered in ascertaining intent.

This contract shall not be construed in favor of or against any party on the basis that the party did or did not author this contract.

Nothing herein shall be construed to make either party a purchaser or consumer of goods of services from the other.

No provision of this Contract shall create in the public of in any member thereof any third-party beneficiary rights, or to authorize anyone not a party to this Contract to maintain a suit for personal injuries, property damage, or and other relief.

XI.

ENTIRETY

This Contract contains the entire agreement between the parties and no representations,

inducements, promises, agreements between the parties not embodied herein shall be of any force of effect.

XII.

AMENDMENT

No amendment, modification, or alteration of the terms of this Contract shall be binding unless it is in writing, dated subsequent to the date of this Contract, and duly executed by the parties.

IN WITNESS WHEREOF, COUNTY and MUNICIPALITY have executed this instrument in multiple duplicates, each which when fully executed shall be deemed to be an original.
