This course does not certify the applicant as a mental health care expert or mental health care service provider. This class is to achieve a voluntary and elite designation. The requirements to achieve this elite and voluntary designation reflect the gravity of the duties.

ORDINANCE NO. 2022-08-9A

AN ORDINANCE AMENDING CHAPTER 28, ARTICLE II, OF THE CODE OF ORDINANCES OF THE VILLAGE OF SURFSIDE BEACH, TEXAS; REPEALING PROHIBITIONS OF ACTIVITIES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR INCLUSION IN THE CODE; AND FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW.

WHEREAS, the City Council of the Village of Surfside Beach, Texas, has determined that adoption of this Ordinance is necessary to the health, safety, and general welfare of the inhabitants of said City and the members of the general public; and

WHEREAS, the City Council finds that this Ordinance was adopted at a meeting which was open to the public and preceded by proper notice, as required by Chapter 551 of the Texas Local Government Code (the Open Meetings Act).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE VILLAGE OF SURFSIDE BEACH, TEXAS:

FIRST, the findings and recitations set out in the Preamble to this Ordinance are found to be true and correct and they are hereby adopted by the City Council and made part hereof for all purposes.

SECOND, That Chapter 28, Article 2, Section 28-23 of the Code of Ordinances of the Village of Surfside Beach, Texas, is amended as follows:

Sec. 28-23. — Recreational Activities.

No person in a park shall:

- (1) Bathing or swimming.
 - Designated areas. Swim, bath, or wade in any waters or waterways in any park, except in the ocean adjacent to any beach.
 - b. Costume. Allow himself to be so covered with a bathing suit as to indecently expose his person or call forth merited criticism.
- (2) Fishing. Engage in commercial fishing in the park or the buying or selling of fish in the park caught in any waters in the park.
- (3) Hunting and firearms. Hunt, trap, or pursue wild life at any time. No person shall exhibit or discharge firearms of any description, or air-rifles,

spring-guns, bow-and-arrow, slings or any other forms of weapons potentially inimical to wild life and dangerous to human safety, or any instrument that can be loaded with and fire blank cartridges, or any kind of trapping device. Shooting into park areas from beyond park boundaries is forbidden.

(4) Picnic areas and use.

- a. Regulated. Attendants shall have the authority to regulate the activities in such areas when necessary to prevent congestion and to secure the maximum use for the comfort and convenience of all. Visitors shall comply with any directions given to achieve this end.
- b. Availability. Violate the regulation that use of the individual fireplaces together with tables and benches follows generally the rule of "First come, first served."
- c. Nonexclusive. Use of any portion of the picnic area or any of the buildings or structures therein for the purpose of holding picnics to the exclusion of other persons, nor shall any person use such area and facilities for an unreasonable time if the facilities are crowded, except as specifically permitted after application under the provisions of section 28-26(c).
- d. Duty of picnicker. Leave a picnic area before the fire is completely extinguished and before all trash in the nature of boxes, papers, cans, bottles, garbage and other refuse is placed in the disposal receptacles where provided. If no such trash receptacles are available, then refuse and trash shall be carried away from the park by the picnicker to be properly disposed of elsewhere.
- (5) Camping. No person shall set up tents, shacks, or any other temporary shelter for the purpose of overnight camping, nor shall any person leave in a park, after closing hours any movable structure or special vehicle to be used or that could be used for such purpose, such as a house-trailer, camp trailer, camp-wagon, or the like.
- (6) Games. Take part in or abet the playing of games involving thrown or otherwise propelled objects such as balls, stones, arrows, javelins, or model airplanes except in areas set apart for such forms of recreation. The playing of rough or comparatively dangerous games such as football, baseball and quoits is regulated to preserve the safety and welfare of the public, except on the fields and courts or areas provided therefor. Rollerskating or skate boarding shall be confined to those areas specifically designated for such pastime.

THIRD, This Ordinance shall be and is hereby declared to be cumulative of all other Ordinances of the Village of Surfside Beach and this Ordinance shall not operate to repeal or affect any of such other Ordinances except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, in such other Ordinance or Ordinances are hereby repealed.

FOURTH, If any section, subsection, sentence, clause, or phrase, of this Ordinances is for any reason held to be unconstitutional, such holding shall not affect the validity of the remaining portions of this Ordinance.

FIFTH, All of the regulations provided in this Ordinance are hereby declared to be governmental and for the health, safety, and welfare of the general public. Any member of the City Council or any City official or employee charged with the enforcement of this Ordinance, acting for the Village of Surfside Beach in the discharge of his/her duties, shall not thereby render himself/herself personally liable; and he/she is hereby relieved from all personal liability for any damage that might accrue to persons or property as a result of any act required or permitted in the discharge of his/her said duties.

SIXTH, Any violation of this Ordinance can be enjoined by a suit filed in the name of the Village of Surfside Beach in a court of competent jurisdiction, and this remedy shall be in addition to any penal provision in this Ordinance or in the Code of the Village of Surfside Beach.

SEVENTH, This Ordinance shall take effect and be in force immediately upon its passage and publication of its descriptive caption twice in the Brazosport Facts.

AN ORDINANCE AMENDING CHAPTER 22, ARTICLE III, OF THE CODE OF ORDINANCES OF THE VILLAGE OF SURFSIDE BEACH, TEXAS; REPEALING APPROVAL REQUIREMENTS OF THE RESERVE POLICE FORCE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR INCLUSION IN THE CODE; AND FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW.

WHEREAS, the City Council of the Village of Surfside Beach, Texas, has determined that adoption of this Ordinance is necessary to the health, safety, and general welfare of the inhabitants of said City and the members of the general public; and

WHEREAS, the City Council finds that this Ordinance was adopted at a meeting which was open to the public and preceded by proper notice, as required by Chapter 551 of the Texas Local Government Code (the Open Meetings Act).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE VILLAGE OF SURFSIDE BEACH, TEXAS:

FIRST, the findings and recitations set out in the Preamble to this Ordinance are found to be true and correct and they are hereby adopted by the City Council and made part hereof for all purposes.

SECOND, That Chapter 22, Article 3, Section 22-62 of the Code of Ordinances of the Village of Surfside Beach, Texas, is amended as follows:

Sec. 22-62. - Appointment, removal, and approval of members.

- (a) Appointment. Members of the police reserve force of the village shall be appointed at the discretion of the chief of police of the village but no person appointed to the police reserve force may carry a weapon or otherwise act as a peace officer until he has been approved by the affirmative vote of a majority of the members of the city council present and voting at a regular or special meeting thereof.
- (b) Removal. Any member may be removed at any time, with or without cause, at the discretion of the chief of police of the village and shall be removed by the chief of police if he is appointed as a temporary member and fails to meet the minimum educational standards provided in subsection (c) of this section, within the period of time specified therein or otherwise fails to meet the standards as set out in this article.
- (c) Approval. The city council may, in their discretion, and with or without cause, revoke their approval the right of any member of the police reserve force to carry a weapon or to otherwise act as a peace officer by the affirmative vote of a

majority of the city council present and voting at any regular or special meeting thereof.

THIRD, This Ordinance shall be and is hereby declared to be cumulative of all other Ordinances of the Village of Surfside Beach and this Ordinance shall not operate to repeal or affect any of such other Ordinances except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, in such other Ordinance or Ordinances are hereby repealed.

FOURTH, If any section, subsection, sentence, clause, or phrase, of this Ordinances is for any reason held to be unconstitutional, such holding shall not affect the validity of the remaining portions of this Ordinance.

FIFTH, All of the regulations provided in this Ordinance are hereby declared to be governmental and for the health, safety, and welfare of the general public. Any member of the City Council or any City official or employee charged with the enforcement of this Ordinance, acting for the Village of Surfside Beach in the discharge of his/her duties, shall not thereby render himself/herself personally liable; and he/she is hereby relieved from all personal liability for any damage that might accrue to persons or property as a result of any act required or permitted in the discharge of his/her said duties.

ORDINANCE 2022-08-09B

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE II, OF THE CODE OF ORDINANCES OF THE VILLAGE OF SURFSIDE BEACH, TEXAS; REPEALING AGENDA PREPARATION ORDINANCES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR INCLUSION IN THE CODE; AND FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW.

WHEREAS, the City Council of the Village of Surfside Beach, Texas, has determined that adoption of this Ordinance is necessary to the health, safety, and general welfare of the inhabitants of said City and the members of the general public; and

WHEREAS, the City Council finds that this Ordinance was adopted at a meeting which was open to the public and preceded by proper notice, as required by Chapter 551 of the Texas Local Government Code (the Open Meetings Act).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE VILLAGE OF SURFSIDE BEACH, TEXAS:

FIRST, the findings and recitations set out in the Preamble to this Ordinance are found to be true and correct and they are hereby adopted by the City Council and made part hereof for all purposes.

SECOND, That Chapter 2, Article 2, Section 2-92 of the Code of Ordinances of the Village of Surfside Beach, Texas, is amended as follows:

Sec. 2-92. – Agenda.

- (a) Contents. The agenda of every regular, special and emergency meeting of the city council of the village shall comply with the requirements of the Texas Open Meetings Act, V.T.C.A., Government Code ch. 551, and shall include the following items, to-wit:
 - (1) Invocation;
 - (2) Roll call of members and other officers;
 - (3) Approval of minutes of previous meeting;
 - (4) Business of visitors not on agenda;
 - (5) New business:
 - a. Public business;

- b. Closed executive session, if any;
- Action taken on matters discussed in closed executive session, if any;

(6) Adjournment.

Provided, however, the agenda for any emergency or special meeting may omit subsections (3), (4) and (5) of this section. Each item of business to be acted upon under "old business" or the "public business" section of "new business" shall be clearly stated to give reasonable notice of the subject matter, but the items of business to be discussed in any "closed executive session" shall be set forth only by use of one or more of the categories contained in the Texas Open Meeting Act, V.T.C.A., Government Code ch. 551, for which such closed session is authorized.

- Preparation. The agenda for all regular meetings shall be prepared by the (b) secretary under the direction of the mayor or the mayor pro tem. The agenda for any special or emergency meeting shall be prepared by the secretary under the direction of the person calling such meeting. The agenda for any regular meeting shall contain any item of old business tabled from a previous meeting and any item of new business, which the mayor or any councilmember determines to place thereon; provided that any item of new business is given to the secretary for placement on the agenda not later than 12:00 noon on the Thursday next, preceding the regular meeting. Any person other than the mayor or a councilmember may have an item placed on the agenda of any regular meeting by making a request to the mayor or mayor pro tem with the same deadline of not later than 12:00 noon on the Thursday next preceding the regular meeting at which the matter is to appear on the agenda. The agenda for any emergency or any special meeting shall contain such items of old business or new business as the person calling such meeting desire to place thereon.
- (c) Posting and distribution of copies of agenda and minutes of preceding meetings. The person responsible for complying with the notice provisions of the Texas Open Meetings Act, V.T.C.A., Government Code ch. 551, shall post the agenda for such meeting within the time required by the act on a bulletin board located at the regular meeting place of the city council and which is accessible to the public at all times. Within the same period of time, such person shall deliver or cause copies of such agenda to be delivered to the mayor and each councilmember, by email or by hand delivery, together with a copy of the minutes of any previous meeting, the approval of which is an item on such agenda.

THIRD, This Ordinance shall be and is hereby declared to be cumulative of all other Ordinances of the Village of Surfside Beach and this Ordinance shall not operate to repeal or affect any of such other Ordinances except insofar as the provisions thereof might be inconsistent or in

conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, in such other Ordinance or Ordinances are hereby repealed.

FOURTH, If any section, subsection, sentence, clause, or phrase, of this Ordinances is for any reason held to be unconstitutional, such holding shall not affect the validity of the remaining portions of this Ordinance.

FIFTH, All of the regulations provided in this Ordinance are hereby declared to be governmental and for the health, safety, and welfare of the general public. Any member of the City Council or any City official or employee charged with the enforcement of this Ordinance, acting for the Village of Surfside Beach in the discharge of his/her duties, shall not thereby render himself/herself personally liable; and he/she is hereby relieved from all personal liability for any damage that might accrue to persons or property as a result of any act required or permitted in the discharge of his/her said duties.

SIXTH, Any violation of this Ordinance can be enjoined by a suit filed in the name of the Village of Surfside Beach in a court of competent jurisdiction, and this remedy shall be in addition to any penal provision in this Ordinance or in the Code of the Village of Surfside Beach.

SEVENTH, This Ordinance shall take effect and be in force immediately upon its passage.

Sec. 4-1. - Prohibited hours for sale of beer.

Beer may only be sold, or offered for sale within the incorporated limits of the village between 7:00 a.m. and 12:00 midnight, on any day except Sunday, and that beer may only be sold on Sunday between 12:00 midnight and 1:00 a.m., 12:00 noon 10:00 a.m. and 12:00 midnight, except permittees or licensees authorized to sell for on-premises consumption may sell beer on Sunday between 10:00 a.m. and 12:00 noon, if the beer is served to a customer during the service of food to such customer.

THIRD, This Ordinance shall be and is hereby declared to be cumulative of all other Ordinances of the Village of Surfside Beach and this Ordinance shall not operate to repeal or affect any of such other Ordinances except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, in such other Ordinance or Ordinances are hereby repealed.
