1) CALL TO ORDER, QUORUM IN ATTENDANCE

Mayor Davison called the meeting to order at 7:00 p.m. and acknowledged that all council members were present.

Mayor Davison asked everyone to pause for a moment of silence and led the Pledge of Allegiance.

3) BUSINESS OF VISITORS NOT ON THE AGENDA –

Lou Golish thanked Pete for checking his water and his water lines.

4) Mayor/council/committee/department head/organization reports.

Chief Phillips – gave the PD monthly activity report.

Michelle Booth - Tourism, festival date January 20

Councilperson Capretta – National night out will be the 1st Tuesday in October;

Councilperson Guzman – thanks to the City for the alert system and being attentive enough during the Hurricane Harvey to call for an evacuation.

Mayor Davison - Gave an update on erosion and damage from hurricane Harvey. Announced that we now have an ISO fire rating of 4, and that is great news.
