AN ORDINANCE AMENDING CHAPTER 1 OF THE CODE OF ORDINANCES OF THE VILLAGE OF SURFSIDE BEACH, TEXAS, GENERAL PROVISIONS; AMENDING SECTION 1.12, GENERAL PENALTIES; CONTAINING A PREAMBLE; SETTING THE GENERAL PENALTIES FOR ORDINANCE VIOLATIONS; CONTAINING A PENALTY CLAUSE THAT EACH AND EVERY OCCURRENCE SHALL CONSTITUTE A SEPARATE OFFENSE; CONTAINING A SEVERANCE CLAUSE; FINDING THAT THE MEETING AT WHICH THIS ORDINANCE WAS PASSED WAS OPEN TO THE PUBLIC AND PROPERLY PUBLISHED FOR HEARING AS REQUIRED BY LAW AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS DESCRIPTIVE CAPTION HAS BEEN PUBLISHED IN THE BRAZOSPORT FACTS.
