COUNCIL MEETING:


- 1) **CALL TO ORDER, QUORUM IN ATTENDANCE**
Mayor Davison called the meeting to order at 5:30 p.m. and declared a quorum was in attendance with Jennie Green-Prats attending via phone.
- 2) **DISCUSS AND TAKE POSSIBLE ON ORDINANCE NO. 2020-03-19 AN ORDINANCE ORDERING THE POSTPONEMENT OF THE 2020 MUNICIPAL ELECTION FROM THE MAY 2, 2020 UNIFORM ELECTION DATE TO THE REGULAR GENERAL ELECTION DATE OF NOVEMBER 3, 2020 IN RESPONSE TO COVID 19 PANDEMIC.**
Motion was made by Mayor Pro Tem Capretta to adopt Ord. 2020-03-19 postponing the May General Election to November 3, 2020. Motion was seconded by Bisso and approved unanimously.


