NOTICE IS HEREBY GIVEN that a Special Meeting of the City Council will be held on Friday, June 19, 2026, at 6:00 PM, at which a quorum of the City Council will be physically present at 1304 Monument Drive, Surfside Beach, Texas 77541. One or more members of the City Council may participate remotely via videoconference call in accordance with Section 551.127 of the Texas Government Code for the consideration of the following items:

1. **CALL TO ORDER & DETERMINATION OF A QUORUM**
2. **INVOCATION AND PLEDGE OF ALLEGIANCE**
3. **EXECUTIVE SESSION**

The City Council will recess its open session and convene into a closed Executive Session pursuant to the Texas Government Code, to deliberate the following matters:

- a) **Section 551.074 – Personnel Matters:** Deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee, or to hear a complaint or charge against an officer or employee, and pursuant to **Section 551.071 – Consultation with Attorney:** Seek the advice of the City Attorney regarding contemplated or pending litigation; specifically regarding complaints, harassment allegations, risk mitigation, and structural direction – Police Chief / Emergency Medical Services (EMS) personnel.
- b) **Section 551.074 – Personnel Matters:** Deliberate the duties, obligations, and professional conduct of a public officer, and pursuant to **Section 551.071 – Consultation with Attorney:** Seek the advice of the City Attorney regarding contemplated litigation, legal liability, and risk mitigation connected to the unauthorized public dissemination of confidential personnel information,

operational interference, and public statements impacting Village operations – City Council Members / Alderman

4. RECONVENE IN OPEN SESSION

The City Council will reconvene into open session to consider and take any necessary action, if any, regarding items discussed in Executive Session.

- a) Consider, discuss, and take possible action regarding administrative directives, operational structure, or risk-management protocols connected to items deliberated in Executive Session concerning public safety personnel.
- b) Consider, discuss, and take possible action regarding administrative directives, governance frameworks, or the duties and professional conduct of public officials.
- c) Consider, discuss, and take possible action regarding the evaluation, agreement terms, and employment status of the City Administrator.
