# 1) QUORUM IN ATTENDANCE, CALL TO ORDER

- Chief Phillips gave the monthly activity report for the Police Department for December 2015.
- Dortha Pekar reported on the Historical Commission's monthly activities and informed Council that the
  Historical Committee did not meet this month. Reported that we have received a draft report from the
  archaeological company regarding the survey done of the old Ft. Velasco site.
- Councilman Guzman thanked the Chief for the children's Christmas party. He also inquired about the pipeline work by LNG and reported that the Tourism/Beautification committee discussed the "adopt a beach" signs.
- Councilwoman Llewellyn reported that the amendments to the Beach Plan should go out to the Texas Register for public comments soon.
