1.) OPEN REGULAR CITY COUNCIL MEETING

Mayor Larry Davison called the special council meeting to order at 7:35 p.m. and stated that a full quorum of council was in attendance.

2.) MOMENT OF SILENCE & PLEDGE OF ALLEGIANCE

3.) BUSINESS OF VISITORS NOT ON THE AGENDA

Brooks Porter asked about the groin project and about the Beach Drive plans. Mayor Davison gave an update regarding both of those items and updated the audience on the completed revetment project.

Charles Spurlin spoke to Council regarding a recent EMS call and asked for better street signage for Middle Drive.

Mr. Altizer expressed his concerns regarding the home at 1934 Bluewater Highway.

4.) Mayor/Council/Committee/Department Head Reports

Ronnie Grant reported to council regarding the Planning Committee.

Dortha Pekar gave an update on the recent Historical Committee meeting.

Peggy Llewellyn reported on the Beach Advisory Committee and stated that the village is waiting for formal comments back from the GLO regarding the changes to the Beach Plan and gave an update on plans for Ft. Velasco site.

Janna Williams reported to council regarding the advertising that will be coming out soon with the *Tour Texas* website and event calendar. She has had inquiries from a group wanting to have a sand castle contest.

Chief Phillips gave the Police Department's monthly report.

Councilwoman Brown gave a big welcome to the new council members.

Mayor Davison also welcomed the new council members.

CONSENT AGENDA:

- A. Consider approval of minutes from the April 14, 2015, council meeting.
- Consider approval of the April 2015 financials.

Councilwoman Brown motioned to approve the consent agenda items. Councilwoman Llewellyn seconded the motion, and council unanimously passed it.

6.) REGULAR SESSION:

A. Discuss and take possible action on naming Troy McMinn as Mayor Pro Tem.

Councilwoman Brown motioned to name Mr. McMinn as Mayor Pro Tem. Councilwoman Llewellyn seconded the motion, and council unanimously pass it.

B. Discuss and take possible action on the vendor ordinance.

City attorney Tim Kirwin explained the ordinance, and discussion ensued. Councilwoman Brown motioned to approve the ordinance with changes. Councilwoman Llewellyn seconded the motion, and council unanimously passed it.

C. Discuss amending the Zoning Ordinance by changing the minimum square foot requirement for commercial businesses to 800 square feet.

This ordinance change was discussed, and the council instructed the City Secretary to go ahead with the legal notices of the public hearing, so council can vote on this ordinance change at a future meeting.

Discuss and take action on sale of tax property by Brazoria County identified as Detenbeck (A0009 B T Archer Div. 1 (BCIC), Block 1, Lot 6 Acres .0836).

Councilwoman Llewellyn motioned to not accept the offer from the Brazoria County tax sale. Councilwoman Brown seconded the motion, and council unanimously passed it.

E. Discuss and take possible action on re-plat of property on Whelk Street.

Councilwoman Brown motioned to approve the re-plat on Whelk Street. Councilwoman Llewellyn seconded the motion, and council unanimously passed it.

F. Discuss and take possible action on approval of Resolution 20150519 designating Mayor Larry Davison to act on behalf of the Village of Surfside Beach dealing with the Texas General Land Office for the purpose of applying for state assistance to clean and maintain the public beach.

Councilwoman Llewellyn motioned to approve Resolution 20151915, designating Mayor Larry Davison to act on behalf of the Village of Surfside Beach dealing with the Texas General Land Office for the purpose of applying for state assistance to clean and maintain the public beach. Councilwoman Brown seconded the motion, and council unanimously passed it.
