1) QUORUM IN ATTENDANCE, CALL TO ORDER

Mayor Davison called the meeting to order at 7:00 pm and announced that a quorum of council was present including Mayor Larry Davison, Councilwoman E. Elizabeth Brown, Councilman Troy McMinn, Councilwoman Peggy Llewellyn, Councilwoman Toni Capretta, and Councilman Dave Guzman Employees Present: Chief Gary W. Phillips, Public Works Director Pete Gutiérrez, City Secretary Amanda Davenport

2) MOMENT OF SILENCE, PLEDGE OF ALLEGIANCE

Mayor Davison asked everyone to pause for a moment of silence and led the pledge of allegiance.

3) BUSINESS OF VISITORS NOT ON THE AGENDA

Brooks Porter asked about the groin project and Mayor Davison explained that we are waiting on the permit from the GLO and we are still in the design phase of the project. Mr. Porter also asked about the Surfside Shores water well and Mayor Davison explained that it has to pass a 36 hour test for inspection and that test is scheduled for some time next week.
