CITY OFFICIALS PRESENT

- 1) OPEN REGULAR CITY COUNCIL MEETING The Mayor opened the meeting at 7:00 PM
- 2) MOMENT OF SILENCE
- 3) PLEDGE OF ALLEGIANCE
- 4) CITIZENS'/VISITORS' COMMENTS TO COUNCIL
 - Mrs. Pavey asked about the telephone alert system purchased by the city. She wanted to know why it was not used. She stated that she felt it should be used when we have elevated bacteria in the Gulf, water quality issues on the island and other such emergencies. Mayor Davison stated that as Mayor he did not feel that the system should be used unless there was an actual emergency that would impact the whole island.
 - Suzan Zachariah was recognized; she wanted to announce that there would be another neighborhood night out to kick off the holidays. It was noted what a success this occasion had been last time.
 - Bob Petty of the audience had a speaker card but it was for an item in the agenda the RV Park Ordinance.
- 5) MAYORAL/ALDERMEN/COMMITTEE/POLICE ANNOUNCEMENTS
 - Chief Phillips read the police activity report for the month and announced the Christmas Party for the kids of Surfside.
 - Dortha Pekar stated that the Historical Commission had not met due to the sudden loss of Jan Grant. Mrs. Pekar was visibly grieved by the loss of Mrs. Grant and the whole

- 2. Discuss and consider allowing louvered enclosures in Surfside Beach.
 - Bob Petty of the audience said "I told you this was legal a year ago" It was noted by Sandra Miller the history of this local ordinance and the restriction of the 300 sq. ft. and that the TWDB applauded the efforts of the city to be stricter than FEMA laws. Sandra then said that if Council wants to allow for full louvered enclosures she could get all rules and regulations and ask Tim to amend the ordinance and then bring it back to Council to adopt. Councilman Gaschler said yes to this, this item was tabled.
- 3. Discuss and consider a petition for annexation of private property.
 - Billy Smith, partner of Howard Street Condos spoke to the Council asking for his land to be annexed. This land is unimproved and is contiguous to the land at the city limits. Billy said that there was ample water and that the public works has water that they waste at the far end due to flushing. Councilwoman Aust asked what the development plans were, Smith said that it would be residential and on the gulf side. A motion was made by Councilman Bisso, seconded by Councilwoman Brown and with all in favor the petition was accepted to annex the land within the ETJ on the far east city limits off Bluewater Highway.
- 4. Discuss and consider amendments to the Surfside Beach Dune Protection and Beach Access Plan.
 - Sandra explained that this was to be an agenda item to consider changes but due to an agreement reached with the GLO to expedite the fee change these changes were placed on hold. No action.
- 5. Discuss and consider approval of the paid holidays for eligible employees for calendar year 2015.

Brooks Porter asked where the new revetment wall would end this time, Mayor said in about the same location and then went into the scope of the project and some of the design features.
