 Motion was made by Councilperson Llewellyn to waive fees pending the 501C3 standing on October 20, 2018. Motion was seconded by Councilperson Marissa McMinn and passed unanimously.
- 10.) Discuss and take possible action regarding "Fair Housing" proclamation. Motion was made to accept the Fair Housing proclamation by Councilman Troy McMinn. Motion was seconded by Mayor Pro Tem Capretta and passed unanimously.
